After the registration, you will receive an email with the confirmation - make sure you've entered a valid email address.

In this confirmation, you will see information about the show days, all registered dogs as well as their classes and competitions.

If you don't receive the email confirmation, it is possible that you are **NOT registered**, in this case, please contact us as soon as possible at [vystava@kynologie.cz](mailto:vystava@kynologie.cz) and provide details about your registration.

We do not accept registrations through email.

Please note, that on **January 1, 2020**, an amendment to the Veterinary Act No. 302/2017 has been in effect. The **vaccination of a dog against rabies** is considered **valid only if the dog is issued with a microchip**, or marked with a readable tattoo made before 3 July 2011.

## Registration guidelines

The copy of the FCI pedigree from both sides, with the owners' name clearly readable, must be included within the registration.

The exhibitor is subject to all FCI and CMKU (Českomoravská kynologická unie) rules and guidelines as well as the show's propositions, upon the acceptance of the registration by organizer.

A copy of the proof of payment needs to be attached to the registration.

The organizer is not responsible for incorrectly filled entry forms. Copies of documents are not given back.

By submitting the registration, the exhibitor grants his/her permission to have their name and address published in the show's catalogue.

The applications and documents sent after the last deadline will not be accepted or considered.

## Classes:

One dog can only be registered in one class on each judging day.

The change of class and registration cancellation **after the last deadline is not possible.**

Division into classes is according to the ČMKU guidelines.

To be eligible for a respective class, the dog must have completed the applicable trial before the date of the registration; this applies for international as well as the respective FCI member national champion title.

## Champions and working classes:

Champion title for Champion class and an International working certificate for Working class need to be included!

**Without an attached copy of a recognized working / champion's certificate** within the registration, the dog will be automatically **moved to the open class.** We charge an additional fee (€10) for changing the class, only possible before the end of the last deadline.

## Payments and discounts

- The date of the payment determines the deadline fees for each deadline, not the registration date.

- Payments for more dogs (within one registration, with an identical owner) need to be paid in total and **not separately.**

- Payments for more dogs (within one registration, with an identical owner) need to be paid in total and **not separately.**

- **Discount** for multiple dogs is not provided.

- An additional **change of ownership** within the registration will be considered a **new/separate registration** under a new name and the full registration fees will apply.

- **Cancellation** of the registration by the 3<sup>rd</sup> deadline = 10 €.

- **Reclassification** of a dog to another class at the request of the exhibitor possible only **until the 3<sup>rd</sup> deadline** = 10 €.

- **Discount 25 %** for the **registrations of Czech national breeds** before the **first deadline, for the following breeds:**

## **Entry forms**

Will be available through the dogoffice account once published, usually 10 days before the show. Exhibitors with a dogoffice account will receive a download link through the email. The entry form also acts as a ticket for the show (one registered dog=one free entry). The entry form includes the information about all registered dogs and their classes, catalogue and ring numbers. In cases where there was no email address included within the registration, we will send the entry form by post. Should the exhibitor not receive the entry form within the given timeframe, he/she should immediately contact the show organizers at [vystava@kynologie.cz](mailto:vystava@kynologie.cz) and provide details about registered dogs.

## **Veterinary conditions:**

**Each dog at the dog show (registered or not) needs to have the dog's pet passport, vaccination card or health certificate with proof of vaccination, in accordance with all the current veterinary conditions and rules.**

**Dogs with cropped ears** (registered or not) will **not be admitted** to the show grounds. (In compliance with the Animal Protection Law No. 246/1992 and No. 77/2004).

**Please note, that on January 1, 2020, pursuant to the amendment to Veterinary Act No. 302/2017 the obligation to get dog microchipped in Czech Republic. Vaccination of the dog against rabies is valid only if the dog is marked with a microchip, or marked with a legible tattoo made before 3 July 2011.**

Dogs from EU and third countries must have valid EU Pet Passport and need to meet the veterinary rules by the EU Regulation 576/2013 from 12.6.2013 and any additional new rules by the EU, or Czechia.

## **General conditions:**

Each registered dog needs to have a pedigree, issued by a stud book, which is officially recognized by the FCI.

An exhibitor is subject to all FCI and CMKU show rules.

**In cases where there are more than 80 dogs in the ring, the critique will not include the written evaluation of the dog.**

All dogs must be registered in a stud book of an FCI member state or in a stud book of a country whose pedigrees are recognized by the FCI.

All dogs are eligible for registration if they and their breed are administered in the FCI studbooks and are within **the age limit required for the respective class in the day of the show date.**

The organizer shall not be liable for any damages caused by the dog or the exhibitor or for the dog's death or loss. Roaming of unleashed dogs shall not be permitted. Females in season, highly pregnant females, breastfeeding females, aggressive dogs and dogs who have undergone surgery to cosmetically alter the dog's appearance shall not be eligible. It is forbidden to treat the coat, skin or nose of the dog with anything that alters the structure, color or form, allowed is only cutting, trimming, combing and brushing. It is not allowed to leave the dog tied up on the trimming table longer than necessary for show preparation. **Owners with dogs who have won the BOB – Prague Winner Award must be present with their dog during the final competition.** Breeds with color varieties will **be judged in the compliance with the FCI provisions and rules.**

Unless otherwise specified, the provisions of the FCI international show rules and ČMKU rules apply. Should the show be cancelled due to objective reasons, all collected fees shall be used to cover show expenses. Bringing small puppies and their sale at the show is not be permitted.

## **Protest:**

Objections against any decisions made by a judge shall **not** be permissible. However, formal complaints concerning violation of show rules and provisions may be filed. Such complaint must be submitted in writing form, against a deposit of 65 EUR, during the course of the show, meaning until the end of judging in the rings (excluding the preparation and the final ring). If a protest is found to be unjustified, this deposit will be forfeited to the organizer of the show. Protest can not be submitted after the show.
